- 1. By now everyone in the community should have received the Bluestem Utilities three rate outlook for the non-regulated utilities. If you have not received this notice, then please contact the Bluestem Utilities directly (1-877-788-7277).
- 2. The URC together with the CSROA has, again, requested a copy of the Sun Rivers Master Agreement. It is our understanding that SRDC has agreed to provide this document to the CSROA. However, we continue to wait for both the KIB's and Bluestem's decision to provide this document to the CSROA.
- **3.** The CSROA will soon be receiving a copy of Bluestem's utility rate model. This model is used for the determination of the Sun Rivers non-regulated utility rates.
- 4. We will continue to search for a rate utility advocate. We will continue to see if there are any benefits of having the CSROA register with the Residential Consumer Intervener Association (RCIA).
