- 5. Committee Updates/Reports
  - (a) Bighorn Report John Nymeyer
    - i) Cart path crossing signs are in place
    - ii) Only golfers' signs to be removed for winter season to allow walkers
    - iii) Update regarding Bighorn shares: individual trying to acquire more shares of Bighorn is apparently at 20%. The Bighorn directors would like to maintain member ownership model.

Appreciation was expressed to Bighorn for allowing community members to utilize golf cart paths for walking in the off season.

## (b) Strategic Governance Committee

The committee is ready to begin looking at structure and framework for CSROA governance. We will need a legal viewpoint to ensure understanding of SRDC head lease as well as neighbourhood leases as a starting point.

  - i) Final documents are in the works for playground portion

  - iii) Iron fencing around playground will be 4' high
  - iv) Meranti client has generously offered to cover 45% of cost, CSROA to cover 55%.
- (b) Bluestem NDA for Utility Rate Model decision
  - i) Discussion of Bluestem NDA sent to CSROA.
  - ii) Still trying to understand agreement as meeting with SRDC was declined
  - iii) Legal advice at this time is not to sign
